

The Future of Mesothelioma in the US and the Increasing Portion of Diagnoses Not Related to Asbestos Exposure: Estimation and Forecasting

Jorge R. Gallardo-Garcia, PhD Principal Bates White

The presentation will cover an introduction to the models that have been developed to estimate and forecast the number of mesothelioma diagnoses and those models' evolution over time.

- Brief overview of the forecasting of mesothelioma diagnoses and how models have evolved over time.
- Presentation of the Bates White Incidence Model, which identifies the portion of diagnoses that are not caused by exposure to asbestos-containing products.
- The results of the model suggest that, 10 years ago, about 30% of mesothelioma diagnoses was not related to asbestos exposure. Nowadays, that percentage is about 40% and the model predicts that it will be more than 50% by the year 2020.

- The results of this research raise several questions with respect of the future of the asbestos litigation of mesothelioma claims:
 - How causation in mesothelioma cases will play a role in future trials?
 - How will this affect the way in which mesothelioma claims are pursued by plaintiff firms and defended?
 - o How will the asbestos litigation system react to the growing portion of mesothelioma cases with tenuous or no linkage to asbestoscontaining products' exposure?
 - o How will this issue affect the number of mesothelioma claims filed, the number of claims settled, and settlement amounts?

Claims Against Equipment Manufacturers for Defective Products Made and Sold by Third-Parties

Traditional concepts of product liability law dictate that a product manufacturer is legally responsible only for those products that the manufacturer made, sold, or otherwise placed into the stream of commerce.

Recently, numerous courts across the country have confirmed that this legal standard precludes liability when individuals and entities beyond the control of a defendant equipment supplier chose to use asbestoscontaining materials with or near the defendant's industrial and maritime equipment products.

The presentation will trace the history of the third-party product liability doctrine, and analyze various exceptions to the general rule that have arisen over time. The audience will be left with guiding principles, which should apply to all types of products and situations going forward.

Defense of Lung Cancer Cases – Is Asbestos really a cause regardless of smoking history?

There has been a dramatic increase in lung cancer claims being filed over the last few years. Lung cancer is the leading cause of death in men – and the leading cause of lung cancer is smoking. That has been no secret for the last 50 years. Yet Plaintiff attorneys are on a mission to drive up settlement numbers by filing thousands of new claims while defendants seem reluctant to fight back.

Well in excess of 90% of all cases have one cause for the disease – cigarettes. These cases are winnable. If the plaintiff smoked, the story is easy – smoking caused lung cancer and asbestos had absolutely nothing to do with it. If plaintiff did not smoke but has lung cancer – then unless he

had massive exposures to asbestos products other than gaskets and packing and has been diagnosed with underlying asbestosis – there is no link to your product. Smoking and addiction DOES NOT excuse a failure to follow package instructions and warnings that have been on cigarettes for 50 years; in the newspapers or TV; , or warnings given by friends, medical personnel and parents since the 1960s.

Your company is being sued for failing to warn – know the history on cigarettes, asbestos and warnings.

Listen, Learn & Discuss:

- Failure to Warn Really? After cigarettes began waning in 1965/66 there is nothing a warning on your product that would have changed what the worker did.


