As an employer, one of Bates White's greatest strengths also happens to be the very thing that its clients are looking for: the depth of talent and knowledge of senior members of the firm. Given the firm's size, tapping that knowledge and learning from it is often on the individual consultant, rather than arranged as part of a formal training program, but the plus side of that equation is that insiders report an environment where most colleagues are only too happy to share their accumulated wisdom.

Firm Culture

- "This company is clearly a great place to work, especially to start one's career. The on-the-job training and responsibility opportunities are exceptional and typically result in great career opportunities both inside and outside the firm. For undergraduates, this is a great place to acquire experience prior to graduate school. Though there are no formal placing mechanisms, our consultants usually get accepted at the top programs they apply to."
