As an employer, one of Bates White's greatest strengths also happens to be the very thing that its clients are looking for: the depth of talent and knowledge of senior members of the firm. Given the firm's size, tapping that knowledge and learning from it often is done by the individual staff member, rather than arranged as part of a formal training program, but the plus side of that equation is that insiders report an environment where most colleagues are quite happy to share their accumulated wisdom.
