

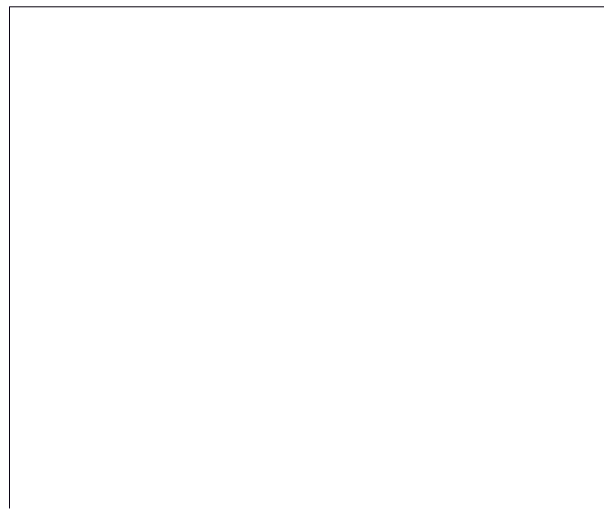
NJBIZ announces 2022 Leaders in Law honorees
