American Honda Finance Corp.* The Court's ruling in favor of the Defendant thwarted a potential class action law suit, and is significant in that it confirms the insulation of assignees of consumer credit contracts from liability for Truth-in-Lending Act (TILA) violations that may be created by the lender.
