# Marijuana Business Law in New Jersey

What are possible federal responses to legalized cannabis? What types of businesses does state law allow, and how does a potential business owner obtain a permit? When are you potentially violating federal law by merely assisting a client?

Mr. Flanagan will focus on the topic of "Federal Responses to New Jersey Marijuana Law" from 9:00am – 9:30am. His presentation will address:

- Current Federal enforcement priorities
- Federal memos and contradictory messages
- Possible legal consequences to cannabis consumers under Federal law, including the Gun Control Act of 1968 and Federal Housing Assistance
- State agencies and Federal funding
- Preemption and the Controlled Substances Act

Mr. Flanagan concentrates his practice in litigation, including substantial work in all aspects of both state and federal civil and criminal litigation pre-trial, trial, and appellate practice. His experience is focused in the areas of banking and creditors' rights, white collar criminal defense, landlord-tenant disputes, personal injury, community association law, and commercial litigation.
