As the scope of the cannabis industry in New Jersey expands, what should in-house counsel know about the current state of the law - on both the local and federal levels - as well as what might be on the horizon? This timely presentation will address recent and proposed legislative actions and their impact on various legal disciplines, including real estate, general litigation, employment matters and other corporate considerations. Panelists will explore current regulations governing the acquisition and expansion of cannabis-related businesses, including banking issues such as securing day-to-day banking and financing for operations. The program will feature an overview of real estate issues including selecting a location and tailoring a purchase agreement or lease, insurance issues in terms of coverage for liability and casualty, and other related topics. The program will also provide guidance for dealing with HR and employment issues including the lawful use of background checks, necessary accommodations under the Americans with Disabilities Act, and avoidance of potential adverse employment action litigation under state and federal anti-discrimination laws.
