## Good and Workmanlike Manner in the Construction Industry: Duty, Fact, or Legal Fiction?

Workmanship issues permeate a construction project, from contract negotiation to final completion. This webinar will take a deep dive into these workmanship issues and learn their impact on a project. After covering a general definition and overview of good workmanship, the presentation will turn to the legal sources of workmanship duties, including express duties set forth in the contract documents as well as implied duties as a matter of law. The agenda will also address sources of good workmanship requirements in statutes and regulations and will examine the claims and dispute resolution process involving workmanship. Attendees will gain an understanding of the elements of causes of action for breaches of express and implied duties of good workmanship and will learn about the forum for prosecuting these claims, whether it is arbitration or a court of law.
