Ms. Balsamo provides legal and policy advice in connection with all aspects of the Bar's operations, including legal representation, legislative and appellate advocacy, judicial administration, policy and corporate governance guidance, strategic planning, and more. She will bring her unique perspective and key insights to the discussion of key ethical issues.
