He is a charter member of the American College of Real Estate Lawyers and of the Community Associations Institute's (CAI) College of Community Association Lawyers and is a life fellow of the American Bar Foundation. He is a recipient of CAI's prestigious Byron Hanke Award for outstanding contributions to community associations. Mr. Smith is the primary author of New Jersey Condominium and Community Association Law published by Gann Law Books.
