## LICENSING AND REGULATORY COMPLIANCE

Hemp and cannabis regulation varies from country-to-country, state-to-state, and, in some jurisdictions, even between municipalities. Each jurisdiction may have its own licensing process, regulatory landscape, reporting requirements, testing requirements, and other specific obligations. For example, New York's Marihuana Regulation and Taxation Act ("MRTA") generally prohibits vertical integration between licenses, but there are some exceptions. In New York and in other jurisdictions, we help our clients know and understand the regulatory landscape, meet applicable licensure requirements, anticipate compliance issues, and limit exposure when mistakes happen.

# MERGERS AND ACOUISITIONS

Recent years have seen a boom in transactions in the medical cannabis and hemp industries, as well as the adult-use (or "recreational") industry. The Hodgson Russ team helped clients position themselves with strategic acquisitions, including some of the largest transactions in the history of the industry. Our experience gives us insight into the industry's complex regulatory requirements, the potential impact of a change of control on a target company's pending license applications, and ways to structure transactions accordingly. ### **SECURITIES**

Running a hemp or cannabis business is capital-intensive. Today's operators range from startups with a few angel investors to publicly traded companies listed on national exchanges. Whatever the size of your company, Hodgson Russ has the securities expertise to structure your business' capital

raise in a manner that satisfies the registration requirements under the U.S. Securities Act, or is otherwise exempt from such registration. Although it remains a challenge for businesses with U.S. hemp cannabis operations to be listed on a U.S. stock exchange, there has been a flurry of fundraising activity by such companies on various public stock exchanges in Canada, where the cannabis industry is fully legalized. Hodgson Russ does not practice Canadian law, but through our extensive cross-border contacts and office in Toronto, we can assist your company in finding the right partners for a going-public transaction north of the border.

## CORPORATE STRUCTURE AND GOVERNANCE

Like New York, many states limit the types of businesses and individuals who can own and operate as hemp or cannabis cultivators, processors, distributors, or retailers. Moreover, regulators insist on strict adherence to corporate formalities. Your business will need to follow the law and best practices applicable to corporate governance, and keep meticulous documentation. Hodgson Russ corporate attorneys have extensive experience helping individuals, startups, and established companies with the myriad issues and regulations applicable to the operations of corporate boards and the conduct of their directors. ## FEDERAL, STATE, AND LOCAL TAX

In an extraordinarily regulated industry, your business cannot afford to make mistakes with its books. Your business needs a carefully-structured tax plan, pristine recordkeeping, and a team of experienced professionals to address any IRS inquiries. Hodgson Russ is a leading firm for New York State, New York City, and multistate tax matters including planning, compliance, litigation, and damage control. Our

professionals have the breadth and depth of experience necessary to anticipate tax questions arising from new, ever-changing laws and regulations specific to the cannabis industry. For example, in New York, adult-use cannabis sales are subject to both a state-wide tax (9%) and local tax (4%). In addition, distributors must remit taxes based on the THC content of the products they sell. Cannabis flower is taxed at 0.5 cents per milligram of THC, cannabis concentrate is taxed at 0.8 cents per milligram, and edibles are taxed at 3.0 cents per milligram. ### LITIGATION

Whenever laws and regulations are new and untested, litigation is sure to follow. Municipalities adopting their own rules have seen challenges. Approval of cultivation and processing facilities has been challenged under environmental review statutes. Disputes over patents and other intellectual property in cannabis products have received national attention. Hodgson Russ has significant litigation experience representing its clients in land use, intellectual property, and business disputes. We also have broad expertise across a spectrum of issues, allowing us to anticipate and handle novel theories from Day 1, including products liability, business torts, contract litigation, and environmental and toxic torts. ### LABOR AND EMPLOYMENT

If an employee tests positive for cannabis use, can he or she be terminated for cause? The answer varies among jurisdictions.
