Hodgson Russ represented special act school district client in the acquisition of a school campus. Our attorneys acted as examining counsel with respect to insuring both the fee title and the related leasehold interests granted to secure bond financing in excess of \$5 million.

On behalf of a client acting as the underwriter, Hodgson Russ attorneys reviewed and provided commentary analysis of the preliminary and official statements for a \$20 million charter school bond issuance a New York State charter school. We prepared the due diligence questionnaire, drafted the bond purchase agreement, and worked on finalization of the documents required for the transcript verifying the transaction.

Represented a private school in the negotiation of AIA design and construction agreements for approximately \$3.2 million construction of new science building.

Represented a charter school client in the negotiation of design and construction contracts, AIA B132-2009 Construction Manager as Advisor, for an approximately \$15 million dollar project to construct a new elementary K-5 school.

Hodgson Russ advised an educational institution with respect to the federal tax issues upon the sale of a building with outstanding tax-exempt bonds. The advice involved an analysis of available IRS remedial actions to preserve the tax-exempt status of the bonds, including a redemption of the bonds and use of the disposition proceeds for an alternative qualifying use.

Hodgson Russ represented a school district in special education litigation spanning multiple years that addressed special education programming and services provided to a student within the district. In the initial litigation, Hodgson Russ was able to have the parents' complaint against the district dismissed in all respects and has continued to defend the district in the parents' appeal to the New York State Education Department Office of State Review.

Hodgson Russ has counseled school district clients through numerous teacher disciplinary matters and has helped negotiate settlements on behalf of school districts to avoid expensive and time-consuming disciplinary hearings.

Under the yoke of a federal class-action lawsuit, a New York State public school district approached Hodgson Russ for help. The suit, filed in the U.S. District Court for the Western District of New York, involved systemic, district-wide special education compliance issues. Over the years, the district was required to expend a considerable time, particularly in the compliance review, and was also required to pay significant fees to the parents' attorneys. A Hodgson Russ team anchored by Ryan Everhart negotiated a settlement with the plaintiffs' attorneys. District Court Judge John T. Curtin ended the federal court's jurisdiction over the district as well as any entitlement the plaintiffs' attorneys had to the district's student records and additional attorney's fees.

Represented school district in alleged "sick building" case commenced by a group of students and teachers against contractors and manufacturers where plaintiffs sought to recover damages for illnesses allegedly caused by exposures to hazardous substances upon return to school following a renovation project. Successfully argued novel interpretation of CPLR 205(a) on appeal to the Appellate Division, which reversed the lower court's denial of motions to dismiss the complaint for repeated failure of plaintiff to comply with court-ordered discovery. Defended plaintiff's appeal of Appellate Division's Order to the Court of Appeals, which affirmed this dismissal based on the CPLR 205(a) argument.

Hodgson Russ's bond counsel, real estate, environment and energy, and education law attorneys work together to assist school districts in capital improvement projects, including school districts' evaluation of environmental impacts under the State Environmental Quality Review Act (SEQRA). The dozens of projects we have worked on include improvements such as new school buildings and sports facilities, additions to existing campuses, roadways, and reconstruction and renovation work.

Provided legal assistance on approximately nine matters for several school districts with a total capital project value of approximately \$66 million dollars.

Hodgson Russ obtained summary judgment in federal court litigations brought by former school board members. The cases represented a variety of constitutional issues as well as interpretations of education law.

Hodgson Russ successfully obtained summary judgment in a federal court action in which a parent alleged that the school district violated the Individuals With Disabilities Education Act for a number of years. In this case, the court rejected the parents' multimillion-dollar demand for monetary damages and affirmed the principle that special education claims become



moot when the applicable school year ends.

Attorneys from Hodgson Russ LLP, led by Hugh M. Russ, III and Julia M. Hilliker, secured a victory on behalf of client Portville Central School District at the New York State Court of Appeals. The Court of Appeals is New York State's highest court. The decision, which protects the school district's statutory right to terminate a non-tenured administrator at any point during a statutorily mandated three-year probationary period, constitutes a victory for all districts and school boards statewide.
