Catherine regularly defends fiduciaries of health and welfare benefit plans governed by the Employee Retirement Income Security Act (ERISA), including plan sponsors, administrators and third-party administrators, against claims brought by plan participants, either individually or as a class action. She also represents securities firms, investment advisors, broker-dealers and brokers in Financial Industry Regulatory Authority (FINRA) arbitrations and litigations, including class actions in both federal and state courts, and in proceedings before the Securities and Exchange Commission (SEC). Catherine has also represented parties in contested Surrogate's Court matters and Article 81 proceedings, and is regularly appointed by the Surrogate's Court as a Guardian ad Litem.

Catherine is a member of the board of arbitrators of FINRA, where she hears and decides issues relating to customer and intra-company disputes. She has also mediated customer disputes involving investment advisors, broker-dealers, and brokers. Catherine also sits on the New York Surrogate Decision-Making Committee as an attorney panel member, where she hears and decides issues relating to consent for major medical procedures for incapacitated individuals. Catherine is a former adjunct professor at the University at Buffalo School of Law, where she taught a course on New York civil practice.

able to recover any amount of their lost investment. A receiver has been appointed, and it is possible the class members will be entitled to additional recovery. Moreover, because this litigation morphed into a class action, victims of the scheme who under normal circumstances could not afford to retain counsel were able to benefit from this judgment.

Hodgson Russ is defending a large healthcare organization in a multi-million dollar ERISA class action related to administration of defined benefit plans and claims of excessive administration and investment fees. Our work includes defending the organization, the Board of Directors' and its committees' actions, decision-making, and execution of their fiduciary duties related to the plans' recordkeeping fees and investment fees.

In a case involving claims of fraud, negligence, and breach of fiduciary duty against a securities broker, Hodgson Russ attorneys obtained an award after hearing from a Financial Industry Regulatory Authority (FINRA) arbitration panel dismissing all claims and expunging the complaint from the broker's record.

Hodgson Russ regularly represents third-party administrators and insurers in connection with claims for disability benefits under ERISA-governed plans, many times obtaining summary judgment dismissing the claims in their entirety.
