Paul R. Comeau, a partner at Hodgson Russ LLP, and Timothy P. Noonan, an associate, both members of the firm's State & Local Tax Practice Group, have been awarded the 2004 Burton Award for Excellence in Legal Writing for their article "Executive Compensation and Employer Withholding: A Closer Look at a Complicated Issue," published in the *Journal of Multistate Taxation and Incentives*, August 2003.

The Burton Award is presented in association with the Law Library of Congress. It honors 20 winners selected from nominations from the top 500 law firms in the United States and 10 winners from leading U.S. law schools.

The 2004 Burton Award will be presented June 14 in the Great Hall of the Library of Congress, Washington, D.C. The keynote speaker will be Paula Zahn, CNN host and moderator. Mr. Comeau will attend the ceremony and accept the award.

William C. Burton, Esq., founder and chairman of the awards, said, "Since our program's inception, we have seen dramatic progress towards plain, clear, and effective legal writing. The award winners exemplify superb legal writing and establish high standards for all professionals to follow."

In addition to being a member of Hodgson Russ's State & Local Tax Group, Mr. Comeau is a member of the International/Cross-Border, Estates & Trusts, General/International Tax, and Government Relations Practice Groups.
