Title VI of the Federal Communications Act, FCC regulations, the National Electrical Code, the National Electrical Safety Code, and a variety of construction standards and regulatory requirements.

#### Wireless Infrastructure, Wireless Facilities Siting

Brian represents private property landlords and local governments on cell siting issues, including cell towers, water tower leases, ground leases, rooftop leases, wireless infrastructure, and wireless facilities siting. He drafts and negotiates wireless ordinances and advises clients on federal and state rules for permit application processing in connection with deploying wireless telecommunications infrastructure. Brian regularly presents at state and national conferences on right of way management, cell tower leasing, and pole attachment contracting.

#### **Technology Transactions**

Brian structures and negotiates custom transactions in the areas of information technology, including managed services and enterprise software licensing. He has assisted clients with technology contracting needs, including pension system implementation and contract compliance. He has drafted and negotiated numerous license agreements, software maintenance agreements, and services agreements, including terms of services, master service agreements, service level agreements, and privacy policies.

### **Experience**

- **Precedent-setting denial of cable franchise renewal.** Moss & Barnett represented the city of Sturgis, Kentucky, which became the first municipality in the country and one of only three under the Federal Cable Act to successfully deny a cable operator's request for franchise renewal. We effectively argued that the cable operator's proposal was not reasonable to meet the future cable-related needs and interests identified by the city. Brian represented Sturgis throughout the renewal process and personally prepared its needs assessment report, which the federal district court cited extensively in upholding the city's denial. *Union CATV, Inc. v. City of Sturgis, et al.*, No. 4:95-CV-72-M (U.S. Dist. Ct., W. Dist. of Ky. at Owensboro, Dec. 29, 1995); *Union CATV, Inc. v. City of Sturgis, Kentucky*, 107 F.3d 434 (6th Cir. 1997).
- Web hosting services agreements. Brian advises Moss & Barnett's accounting firm clients, many of which have large regional or national client bases, on web hosting services agreements. In one transaction, Brian advised on the creation of a master service agreement (MSA) that called for construction of a dedicated third-party data center to host and support our client's applications. Brian structured the MSA to allow the accounting firm's clients to have exclusive use of the data center infrastructure, with appropriate service-level obligations and payment terms structured to meet the client's objectives.
- Contracts creating a client interactive site. Moss & Barnett assisted in the development of
  contract documents required to create a client interactive site, which allows the client's personnel
  to collaborate and communicate with its clients. The site was designed to integrate, manage, and
  maintain customer information systems, including marketing, sales, contracts, inventory, order
  management, purchasing, projects, billing, the call center, and field service. The client's existing
