In particular, John works with lenders that originate and sell multifamily mortgage loans to Freddie Mac and Fannie Mae. In connection with these loans, John is regularly asked to review and resolve matters involving use restrictions, tax increment financing (TIF), low-income housing tax credits (LIHTC), subordinate debt and other layered assistance, housing assistance payment (HAP) contracts, tax exemptions and payments in lieu of taxes (PILOT), public development and performance agreements, and other unique title documents such as reciprocal easements and shared use agreements.
