The client's goal was to obtain a decision that would uphold the discharge and its safety and discipline policies, which had not been strictly or consistently enforced for years. Despite the tendency of labor arbitrators to mitigate discipline in discharge cases, the arbiter denied the grievance and upheld the discharge. The significant value of this arbitration decision is (1) the company's ability to rely on it as precedent for future discipline issued under those safety/discipline policies which had not been strictly or consistently enforced for years; and, (2) the company's political gains in its collective bargaining relationship with the union.
