Goodman, who previously served as Chairman of the Federal Election Commission (FEC), and most recently as FEC Commissioner, will rejoin the firm as a partner on February 20. Mr. Goodman was presidentially appointed to the FEC on October 21, 2013, after the U.S. Senate confirmed his nomination by unanimous consent. He served as Chairman of the FEC in 2014 and Vice Chairman in 2013. During his years on the Commission, Mr. Goodman promoted free speech on the Internet; vigorous free press rights, including for new media; and practical deregulation of political parties.

and private-sector acumen, will be a tremendous asset for our clients who seek advice on high-profile and sensitive compliance issues."

Prior to joining the FEC, Mr. Goodman was in private practice, including two stints at Wiley Rein. He advised several presidential campaigns, and served as general counsel of the Republican Party of Virginia from 2009 to 2013. His prior government service includes four years as legal counsel and policy advisor to the Governor of Virginia, and three years as counsel and special assistant to the Attorney General of Virginia. He also served as chief advisor to the Chairman of the Congressional Advisory Commission on Electronic Commerce.

"Wiley Rein has built the most respected election law practice, with the greatest breadth and depth of expertise, in the nation and I am pleased to return to the firm," said Mr. Goodman. Mr. Goodman has authored several articles on election law, including a chapter on regulation of political speech on the Internet in the book *Law and Election Politics – The Rules of the Game*, and frequently lectures on election law topics. He received his B.A., with highest distinction, from the University of Virginia, and his J.D. from the University of Virginia School of Law, where he served as articles editor for the *Journal of Law & Politics*.

Several other members of Wiley Rein's team have also formerly served at the Federal Election Commission. Among them are former FEC counsel Andrew G. Woodson, who rejoined the firm in October 2015, and Brandis L. Zehr, who also served as FEC counsel and rejoined Wiley Rein in January 2017.
